REGULAR MEETING DE SMET COMMON COUNCIL

September 11, 2019

The De Smet Common Council met in regular session on September 11, 2019, at 5:00 p.m., with the following present: Bret Jensen, Alex Botkin, Lowell Hansen, George Cavanaugh, Norman Whitaker, Jay Slater, Mayor Gary Wolkow, FO Tracey Larson, and City Attorney Todd Wilkinson. Absent: none.

Mayor Wolkow called the meeting to order at 5:00 PM.

ANNOUNCEMENTS: Mayor Wolkow announced that on Friday, September 20th, the De Smet School will be having a homecoming parade starting at 1:45 pm with a pep rally to follow on Main Street at 2:15 pm. Mayor Wolkow asked everyone to take a minute to remember all the responders and people who lost their lives 18 years ago on September 11th. On Saturday, September 7th, Mayor Wolkow was presented a statue as a thank you to the City of De Smet for their support during the official closing ceremony of the Nation Guard Armory in De Smet.

BUILDING/CONCRETE/DEMO PERMITS: Motion was made by Botkin, seconded by Slater, to approve the building permit submitted by Wayne Wolkow - 4 ft. chain link fence, all voting aye, motion carried. Motion was made by Jensen, seconded by Slater, to approve the building permit submitted by American Engineered Products (Michael Wiese) - 72' x 78' warehouse addition to the current structure, all voting aye, motion carried. Motion was made by Jensen, seconded by Botkin, to approve the building permit application submitted by Randy Asleson - 12' x 12' storage shed, all voting aye, motion carried. Motion was made by Slater, seconded by Cavanaugh, to approve the building permit submitted by Mark Purintun - house and garage addition to current residential structure, all voting aye, motion carried. Motion was made by Slater, seconded by Whitaker, to table the building permit application submitted by Jack Mann until a zoning officer can look at the property, all voting aye, motion carried. Motion was made by Botkin, seconded by Slater, to approve the concrete permit application submitted by Richard Smith - 9'x 18' patio and 13'x 22' driveway, all

voting aye, motion carried. Motion was made by Slater, seconded by Jensen, to approve the concrete permit application submitted by Dustin McCune - 14' x 14' patio and sidewalk, all voting aye, motion carried. Motion was made by Jensen, seconded by Whitaker, to approve the demolition permit application submitted by Jennifer Grover - remove front porch, all voting aye, motion carried.

PUBLIC COMMENTS: none.

ISAAC WILDE: Isaac Wilde, owner of Wilde Air Service, met with the council to discuss the possibility of building a containment area at the airport and about applying for the 2020 spraying aerial spraying permit. Wilde currently leases a lot at the airport and would need addition space to for the containment pad. Attorney Wilkinson is going to look for records identifying lots platted at the airport. Wilde has building permit that has been approved by Kingsbury County for the containment area, and an air space study has been submitted to the FAA by the airport engineer. Concerns regarding a chemical spill and cleanup were addressed with Wilde and all agreed that a containment pad would eliminate any concerns of a prevent a contamination issue in the future. Motion was made by Slater, seconded by Hansen, to grant a 30-day easement to use additional land area due to airport project construction and table the request to build a containment pad area at the airport until plat records were obtained, all voted ave, motion carried.

EXECUTIVE SESSION: Motion was made by Slater, seconded by Jensen, to approve going into executive session for contractual items at 5:46 PM, all voted aye, motion carried. Mayor Wolkow declared the council out of executive session at 6:32 PM.

FIRE DEPT. MEMBER: Motion was made by Cavanaugh, seconded by Slater, to approve Mykel Anderson joining the De Smet Volunteer Fire Department, all voting aye, motion carried. Anderson will be replacing Greg Hiles.

2020 ANNUAL APPROPRIATIONS: Motion was made by Cavanaugh, seconded by Hansen, to approve the second reading of the 2020 Annual Appropriation Ordinance No. IV-217, all voting aye, motion carried.

SURPLUS PROPERTY & DEVELOPMENT: Motion was made by Cavanaugh, seconded by Whitaker, to declare property legally described as East 60' of Outlot 11 of the County Auditor's Plat of Outlots in De Smet, and vacated Street right of way lying between Outlot 11 and Lot 5, Block 3 of Ely's Addition, All in the City of De Smet, Kingsbury County, South Dakota, all voting aye, motion carried. Motion was made by Cavanaugh, seconded by Slater, to approve deeding property legally described as East 60' of Outlot 11 of the County Auditor's Plat of Outlots in De Smet, and vacated Street right of way lying between Outlot 11 and Lot 5, Block 3 of Ely's Addition, All in the City of De Smet, Kingsbury County, South Dakota to the De Smet Development Corporation with the condition that the land must be developed within one year, all voting aye, motion carried.

OCTOBER REGULAR MEETING: Due to other meetings, a motion was made by Hansen, seconded by Whitaker, to reschedule the October regular meeting date to October 8, 2019 at 5:00 at City Hall, all voting aye, motion carried.

BUILDINGS/PARKS/POOL: Cole Munger, Supt. of Buildings, Parks, and Pool, presented the council with quotes for a storage shed to be placed at the new baseball field. Quotes received for a 12' x 24'

storage shed were as follows: Castlerock - shed with concrete floor \$11,570.82 & excise tax, or shed with wood floor \$12,227.65 & excise tax; Quality Storage Buildings - shed with wood floor \$6,090.00; and Schubloom Const, Inc. - shed with concrete floor & excise tax \$8,463.78, or shed with wood floor and excise tax \$7,908.88. The council agreed with the prior experience of city personnel, the concrete pad was small enough for the city crew to install. Motion was made by Cavanaugh, seconded by Slater, to authorize the purchase of a 12' x 24' storage shed from Quality Storage Buildings with the total project expenses not to exceed \$8,000.00, all voting aye, motion carried. Discussion was held in regard to moving a garage offered for sale by Wendell Schubloom. After much discussion, it was agreed that the garage was too big for the area it was to be moved to. Motion was made by Cavanaugh, seconded by Jensen, to decline purchasing the garage to be moved from Wendell Schubloom property, all voting aye, motion carried. Supt. Munger also reported that he had contacted a company from Missouri about an annual inspection contract for the sirens. A part has been ordered for one of the sirens. If the part ordered does not fix the issue, we may need to contact the company for additional repairs. Supt. Munger discussed with the council the possibility of keeping the old fire truck to clean culverts, ordering a computer board to have on hand for the crossing signal in 2020, and the floor in the Harvey Dunn School building. Supt. Munger reported that the floor on the north side of the Harvey Dunn School building is spongy and rotting. The floor will need to be repaired and ventilation put under the building to prevent the moisture from damaging the floor in the future. There was also discussion about how to prevent snow from accumulating between the building and chain link fence on the north side of the building.

STATE WATER PLAN: Motion was made by Jensen, seconded by Hansen, to approve the City of De Smet submitting an application to be put on the State Water Plan for the water looping proposed project, and authorize the Mayor as the official to sign documents the State Water Plan, all voting aye, motion carried.

AIPORT PAYMENTS: Motion was made by Slater, seconded by Hansen, to approve pay request #17 in the amount of \$2,405.04 for the Hardstand & taxi lane project, and pay request #7 in the amount of \$247.85 to Helms & Associates for the turnarounds, all voting aye, motion carried. These airport project expenses will be reimbursed by 95% from grant funding.

Personnel: Motion was made by Slater, seconded by Cavanaugh, to approve the City paying for the first CDL testing fee for employees required to obtain a CDL, all voting aye, motion carried. Any retesting fees after the first test will be at the expense of the employee.

CONFERENCEs: Motion was made by Hansen, seconded by Botkin, to approve Street Supt. Petersen and one other employee that does mosquito spraying to attend the Mosquito Control and West Nile Conference on October 9, 2019 in Aberdeen, and Dep. Fin. Officer Hansen attending the Annual Safety & Loss Control Training Conference on November 20th & 21st, 2019 in Mitchell, all voted aye, motion carried.

DE SMET DEVELOPMENT DIRECTOR: Rita Anderson, Director, gave a monthly review that included the following: there will be a ROCS transportation meeting on Friday, September 13th at 1:00 at the Event

Center to discuss potential transportation services for Kingsbury County, a community meeting to discuss community day care needs, The Village Assisted Living Facility held a ribbon cutting and grand opening on Sept. 5, 2019 with people of all ages in attendance, a meeting has been scheduled on September 16, 2019 at 1:00 with ISG and the task force to review the preliminary report from ISG, the De Smet Wellness Coalition has been awarded \$8,000.00 to install AED equipment at several locations, and Anderson continues to work on several large projects.

FINANCIAL REPORTS: Motion was made by Hansen, seconded Whitaker, to approve the August 2019 Cash Balances Report as presented by the Finance Officer, all voting aye, motion carried.

OVERTIME: Motion by Hansen, seconded by Jensen, to approve the overtime hours for the month of August as presented, all voting aye, motion carried.

OTHER: Other non-action items of discussion were as follows: 1) August law enforcement report; and 2) property reviews.

ADJOURN: There being no further business the meeting was adjourned on motion by Hansen, seconded by Jensen.
