REGULAR MEETING DE SMET COMMON COUNCIL November 9, 2022

The De Smet Common Council met in regular session on November 9, 2022, at 5:00 p.m., with the following present: Council members Cole Munger, Bret Jensen, Pam Spader, George Cavanaugh, Shon Asleson, Mayor Gary Wolkow, Finance Officer Tracey Larson, and City Attorney Todd Wilkinson. Absent: Lowell Hansen.

Mayor Wolkow called the meeting to order at 5:00 PM.

PUBLIC COMMENTS: Mark Siefkes wished the council Happy Veteran's Day and commented about the problems of miscommunication.

PROJECT UPDATES: Shane Waterman, Engineer for IMEG submitted a written update for ongoing projects. The Brewster Street wastewater project has been completed and in the one-year warranty period. The utility mapping and survey work is still progressing and will be competed soon.

2021 AUDIT: Motion was made by Jensen, seconded by Cavanaugh, to accept and sign the engagement letter for the 2021 Audit submitted by Grant & Williams, Inc. in the amount of fees not to exceed \$15,000 for the audit, \$10,000 for the single audit (required due to federal grant regulations), and \$750 for travel, all voting aye, motion carried.

STREETS: Street Superintendent, Ryan Petersen met with the council and gave a brief update. The streets have been swept for the fall season and if the weather stays clear, the street department will do more patching; the equipment is ready for winter snow removal; and the new patch trailer has been put inside the shop building for storage during the winter. The council asked Supt. Petersen to check streets lights that are out.

EXECUTIVE SESSION: Motion was made by Asleson, seconded by Cavanaugh, to approve going into executive session at 5:21 pm for legal consultation, all voting aye, motion carried. Mayor Wolkow declared the council out of executive session at 6:00 pm.

ZONING APPLICATION FEES: After discussion of the current zoning fees, motion was made by Spader, seconded by Cavanaugh, to approve and adopt Resolution 2022-12, amending the zoning fees, all voting aye, motion carried.

Variance Permit Application - \$100.00 and publishing and certified mailing expenses

Special Exception Permit Application - \$100.00 and publishing and certified mailing expenses

Re-zoning Permit Application - \$200.00 and publishing and certified mailing expenses

NOW, THEREFORE LET IT BE RESOLVED, that the zoning permit application fees will be effective January 1, 2023.

HEALTH INSURANCE RENEWAL: A contract from The Health Pool of South Dakota for employee health insurance with a renewal premium of \$7,234.22/month was reviewed. The new premium would be an increase of 4% to keep the current policy. Motion was made by Cavanaugh, seconded by Jensen, to renew the Plan B health insurance policy for the fulltime city employees, to be effective January 1, 2023, all voting aye, motion carried.

DE SMET DEVELOPMENT: Jamie Lancaster, Director for the De Smet Development Corporation, gave an update on current activities and projects being worked on by the Development Corporation as follows: The Master Plan Task Force Main Street Committee will be meeting to discuss goals for adding specialized features while the City is doing the Main Street Infrastructure Project; additional housing; the Minimaker Camp that will be held for one day with the high school students; and presented state economic statistics.

SURPLUS PROPERTY: Motion was made by Cavanaugh, seconded by Asleson, to table declaring the 1998 Chevrolet Pumper Truck as surplus property until the pump is fixed, all voting aye, motion carried.

FIRE DEPARTMENT RADIOS PROJECT: The City of De Smet was awarded \$35,945.31 to purchase seven (7) radios for the fire trucks and four (4) handheld radios for the De Smet Volunteer Fire Department. Following the grant application and awarding, the price of the radios has increased by \$5,660.86. Motion was made by Cavanaugh, seconded by Jensen, to approve the City paying for the additional \$5,660.86 expense for the radio purchase that is not funded by the grant, all voting aye, motion carried.

PROJECT PAYMENTS: Motion was made by Munger, seconded by Asleson, to approve pay request #10 in the amount of \$5,499.18 to Helms & Associates for the Airport AWOS III project, all voting aye, motion carried. The airport project expenses will be reimbursed by 95% from grant funding.

CONTINGENCY TRANSFER: Motion was made by Cavanaugh, seconded by Munger, to approve transferring \$7,553.00 from the Contingency Department to the Buildings Department for the City Hall flooring project, all voting aye, motion carried.

HOSPITAL CD: Motion was made by Cavanaugh, seconded by Spader, to approve transferring \$200,000.00 from the Hospital MMDA account to the Hospital CD when the CD renews in December, 2022, all voting aye, motion carried.

FINANCIAL REPORTS: Motion was made by Jensen, seconded by Asleson, to approve the October, 2022 Cash Balances Report as presented by the Finance Officer, all voted aye, motion carried. Finance Officer Larson also reported that the Water Looping Project SFR Loan #2 repayment will begin in January, 2023.

OVERTIME: Motion was made by Spader, seconded by Cavanaugh, to approve the October, 2022 overtime as presented, all voting aye, motion carried.

OTHER: Other non-action items of discussion were as follows: 1) October law enforcement, contract hours, ad coverage; and 2) property reviews.

ADJOURN: There being no further business the meeting was adjourned on motion by Cavanaugh.
